AFFIDAVIT OF STACY ADKINS

COMES NOW the affiant, STACY ADKINS, after being first duly cautioned and sworn, states, as follows:

1. I am Deputy County Clerk in the Office of Justin Crigler, County Clerk of Boone County, Kentucky.
2. I currently serve as the Elections & Voter Registration Supervisor and have so served since March 2021.
3. To the best of my memory the timeline of events following the election held on November 5, 20224 was as follows:
 - a. Following the night of the election, the Board met on November 7, 2024, to complete the hand to eye audit as required by statute.
 - b. At the conclusion of the audit, as noted in the official minutes of the meeting of the Board of Elections, I reminded the members of the Board of Elections that they would need to stop by my office before 10:00 a.m. on Friday, November 8, 2024, to sign the

could send this to the Secretary of State's office prior to the 12:00 pm deadline.

c. As reflected in the official minutes, I told them they would need to come in at their convenience and I specifically recall Board member, Steve Mueller, commenting that he would have to come in early on Friday because he was going out of town.

d. My recollection is that he was the first to stop by my office and sign on Friday, November 8, 2024.

e. Board member, Janet Cowen, came in later that morning.

f. Sheriff Mike Helmig was not at the audit on Thursday, November 7, 2024, and was unable to sign on Friday, so after I obtained the signature of Justin Crigler, I faxed the signed document to the Secretary of State on November 8, 2024. Based upon additional research I have been able to ascertain that on the morning of November 8, 2024, I faxed these for the first time at 10:41 am and was later required to resend the fax which I did at 11:04 am as noted on the document. The fax report I printed shows that it went through at 11:09 am.

g. At no time on November 8, 2025, were any three members of the Board of Elections together in my office where the document was signed nor, to the best of my recollection, were the three signing members in the office of the Boone County Clerk at the same time on that day.

h. At some point, following the submission of the certification of election results (Official Count and Record of Election Totals) and November 14, 2024, I began the process of preparing the individual certificates of election for each of the successful candidates.

02:42:11 PM i. When preparing these certificates, I knew they had to be completed and forwarded to the elected candidate by Monday, November 18, 2024, as required by statute, so I randomly chose to date the certificates, November 15, 2024, as I did not know when everyone would be signing.

j. I recall contacting each of the Board of Election members when the certificates were ready to sign and informed them that they would be available in my office. I reminded each of them that they needed to stop by before Friday, November 15, 2024. I do not recall how these contacts were made.

k. I do not recall in what order the members signed the certificates but from my review of my personal emails, I found that I emailed the completed documents to myself in order to save the copies as required by statute, and the time stamp on this email was November 14, 2024, at 2:16 pm.

1. At no time following the submission of the Official Count and Record of Election Totals on November 8, 2025, and November 14, 2024 when the certificates were submitted, did a quorum of the Board of Elections convene, and to the best of my recollection at no time during this period were any three members of the Board of Elections together in my office nor, to the best of my recollection, were any three members in the office of the Boone County Clerk at the same time during this period of time.



g. During the post-election process, at no time following the hand audit, did a quorum of the Board of Elections convene between November 8 and November 15, 2024, and to the best of my recollection at no time during this period were any three members of the Board of Elections together in my office, or Stacy's Adkin's office, nor any other site.
